Introduction

Towards realization of a sustainable society in harmony with the environment, USHIO INC. observes laws and regulations and is tackling environmental preservation and striving for effective use of limited resources.

To this end, the Harima Division version of the Green Procurement Standards was formulated in December 2003. Subsequently, the first edition of the Green Procurement Standards for the entire Company was formulated in December 2006, followed by the second edition in March 2010 and the third edition in March 2012. These standards are in compliance with laws and regulations in Japan and overseas and are aimed at managing chemical substances contained in products.

We will promote "Green Procurement" vigorously. However, this will require a comprehensive measure which involves the cooperation of both USHIO and our suppliers. We would like to request our suppliers understanding and cooperation with our Green Procurement Standards.

1. Purpose

USHIO created the "Green Procurement Standards" as guidelines concerning the purchase of materials by pursuing the maintenance and improvement of environmental preservation activities under its basic environmental policies to fulfill its social responsibility through business activities that correspond to as well as take into consideration the demands of the Earth, society and our customers. USHIO will promote procurement together with suppliers in accordance with these Green Procurement Standards.

2. Scope of Application


- (1) The standards shall apply to materials used for USHIO products such as parts, semi-finished products (assembled parts, unit parts), primary raw materials, packaging materials and auxiliary materials such as operation manuals.
- (2) The standards shall also apply to things having direct contact with product structure materials or any substances used that could possibly remain in materials, such as cleaning agents, during the production process.

However, the standards do not apply to the following materials.

- (a) Materials supplied by USHIO
- (b) Specified materials approved by USHIO that contain prohibited substances

3. USHIO's Approach to Green Procurement

As indicated in the diagram below, USHIO gives priority to suppliers with excellent evaluation results based on concepts such as "Establishment of Environmental Management System" and "Evaluation System for Controlling Chemical Substances Contained in Products." Furthermore, only materials that satisfy the "Approval Standards for Materials" will be procured.



Note: Formats 1 to 4 are used for preparing documents according to respective purposes.

4. Establishment of Environmental Management System

- (1) USHIO requests suppliers to establish environmental management systems (certification such as ISO 14001, Eco Action 21, etc.) based on compliance with laws and regulations.
- (2) Priority for procurement will be given to suppliers who already have established environmental management systems.

5. Evaluation System for Controlling Chemical Substances Contained in Products

- (1) USHIO will evaluate suppliers based on such documents as Appendix 1 "Self-Evaluation System for Controlling Chemical Substances Contained in Products (Format 1)."
- (2) USHIO will evaluate the information provided and may conduct a review and request for resubmittal as necessary or an environmental audit as necessary.
- (3) Suppliers with outstanding evaluation results will be given priority, and their materials will be procured.
- (4) Suppliers that cannot meet the standards will be requested to improve their environmental management systems by USHIO.

6. Survey and Approval of Materials

Only materials that satisfy requirements for the following items and meet the standards will be procured.

(1) "Non-use Certificate Guarantee of Prohibited Chemical Substances" (Prerequisite)

The non-use guarantee of prohibited substances in Supplement 1 "Chemical Substance Control Level Classification Table" will be submitted. The format is based on Appendix 2 "Non-use Certificate Guarantee of Level 1 Prohibited Substances" (Format 2).

- (2) "Chemical Substance Content Survey" (Prerequisite)
 - Survey Response Tool AIS Format (Format 3)

(3) Proof of Analysis (Pre-requisite for indicated materials)


There will be cases where USHIO will request the "Proof of Analysis" for appointed materials to be submitted as an attachment in accordance with instructions provided.

7. Survey regarding REACH Regulation

Surveys regarding SVHCs stipulated by the REACH Regulation will be requested

using the following survey form: Survey Report of SVHCs Stipulated by REACH Regulation (Format 4).

Currently, 155 substances are subject to survey (as of July 2014). Reinvestigation will be conducted when substances are added at a later date.



9. Evaluation Period

USHIO will conduct surveys on environmental initiatives and materials related to green procurement as follows.

(1) Survey on Environmental Initiatives

USHIO will request a survey on the establishment of environmental management system and updates of the evaluation system for controlling chemical substances contained in products

(2) Materials Survey

With regard to the materials specified by the department in charge of procuring materials, USHIO will request a survey on and updates of the "Non-use Certificate Guarantee of Prohibited Chemical Substances," "Chemical Substance Content Survey" and "Proof of Analysis."
