USHIO INC. announced today that, at the meeting of the board of directors held on January 29, 2016, a resolution was passed to repurchase its own shares pursuant to the provisions of Article 156 of the Companies Act, as applied mutatis mutandis pursuant to the provisions of Article 165, Paragraph 3 of the Companies Act.

1. Reason for Purchase of Treasury Stock

To raise capital efficiency and enable the implementation of an agile capital policy.
